

MANGO LOVES LOOKBOOK.NU CONTEST RULES

The aim of these rules (hereinafter the "Rules") is to regulate the competition organised by the company PUNTO FA, S.L. (commercialised under the name "MANGO"), with registered company address at Palau-solità i Plegamans (Barcelona), calle Mercaders, 9-11 Pol. Ind. Riera de Caldes.

PRIZE(S)

Five winners chosen on their creativity, votes, and originality are selected by Mango on October 24th, 2011. The five winners will receive a trip to Mango's headquarters in Barcelona, Spain for a one of a kind photoshoot. Airfare, accommodations, and Mango clothing valued at \$500, are provided to the winners. The trip shall take place approximately during the second week of November.

NOTIFICATION OF THE 5 FINALISTS

On October 25th 2011 MANGO will contact the 5 finalists by email to the address registered on the site.

All notification will be made to the address provided by the finalist. MANGO shall be exempt from any liability on this subject.

The finalist must expressly accept the prize within a period of five (5) calendar days following receipt of said notification. In order to do so, they must reply to the e-mail of notification sent. If the finalist fails to do so, MANGO will select a new finalist who must accept in the same delay and conditions previously mentioned. In case the prize is cancelled or cannot be enjoyed due to the finalist, this latter will automatically lose any right in connection with the prize.

The 5 finalists must be of legal age and shall send to MANGO a copy of their ID Card or Passport when accepting the prize.

LEGAL CONDITIONS

Any abusive or fraudulent use of these Rules shall give rise to the participant being disqualified from the competition. By way of example but without limitation, abuse or fraud shall be deemed to have occurred when a participant registers on the Website using a false identity or the unauthorized identities of third parties.

MANGO shall be exempt from any liability in the event of any errors existing in the data provided by the finalist that prevents them from being identified.

Similarly, MANGO shall not be liable for the services provided by any other associated company to the finalist as a result of the prize awarded.

MANGO reserves the right to cancel the competition, either temporarily or definitively, for reasons in both cases of force majeure, unforeseen or unpredictable circumstances or fraud.

MANGO reserves the right to make whatever modifications prove necessary to ensure the success of the competition when just cause or force majeure impede it from being carried out in the manner described in the present Rules.

For any dispute that may arise from the interpretation of the present document, the parties submit to the jurisdiction of the Courts and Tribunals of Barcelona.

The awarding of prizes will be subject to the current tax legislation of individual countries.

PERSONAL DATA

MANGO informs participants that the finalist personal details will be forwarded to any organisations intervening in the management and delivery of the same, such as courier companies, travel agents, etc.

MANGO shall establish the technical and organisational resources necessary in order to guarantee the safety of computerised files, treatment centres, premises, equipment, systems, programmes and persons who intervene in the computerised treatment of personal data in the manner prescribed in the legislation.
